How do I register for the annual convention?

- Visit <u>www.wsra.org/Convention</u> to access the online registration link.
- Register by the Early Bird registration date to save!
- If you are an existing user of the WSRA website, enter your username and password. Check the mailing address on the Convention Program booklet or a WSRA publication such as the WSRA *Update* or *Journal* to find your username and expiration date.
- If you are a new user *or if your WSRA membership is more than 30 days past the expiration date* enter your email address. The email address will become your username.
- If someone is registering for you, please provide that person with your user name and contact information. Use the registrant's name only rather than the person is entered the information.
- There is no need to submit a separate membership form; join or renew for an additional \$37 as a part of the registration form.
- Please know that the nonmember registration fees are at a higher rate.
- If your school or district requires a purchase order, please enter the purchase order number in the online form.
- If you need to transfer your registration to another person, you must contact Joyce at wsra@wsra.org.

What is the WSRA Refund Policy?

- Unless otherwise noted, refund requests should be postmarked or sent electronically two weeks before the event to WSRA at wsra@wsra.org. The designated date for the convention is printed in the convention program booklet.
- 2. A cancellation must be received by WSRA at wsra@wsra.org by the designated date in order to receive a partial refund. A \$60 processing fee will be applied.
- 3. If the payment was submitted via a check or direct deposit and the cancellation was received by the designated date, the refund check may be issued by the WSRA Treasurer after the event. Cancellation fees do apply.
- 4. If the payment was submitted via an accepted credit card payment and the cancellation was received by the designated date, the refund may be issued by credit back to the credit card used. An email notification will be emailed. Cancellation fees do apply.
