Humanizing Assessment: Re-Energizing Student Learning



Dylan Wiliams is Emeritus Professor of Educational Assessment at University College London. In a varied career, he has taught in inner-city schools, directed a large-scale testing program, served a number of roles in university administration, including Dean of a School of Education, and pursued a research program focused on supporting teachers to develop their use of assessment in support of learning. "*Inside the Black Box*" is a seminal research study by Black and Wiliams that shed important light on the kind of assessments that improve student learning, including student self-assessment."

Peter Dewitz is a Professor at Mary Baldwin College, a researcher at the Harvard Graduate School of Education, and a consultant to school districts around the country directing school- and district-wide reading reform efforts. His research efforts focus on reading comprehension and the affect commercial reading programs have on reading instruction. He is equally concerned about the rising dominance of commercial assessment programs and how they influence the thinking of educators and the direction of instruction.





Peter Johnston is Professor Emeritus at the University at Albany, State University of New York. His current research explores links among classroom talk, reading engagement, and children's social, emotional, and literate development. Johnston's book *Choice Words* (Stenhouse, 2004) has "demonstrably and positively influenced literacy teaching in classrooms and districts nationally." He is a member of the Reading Hall of Fame. Peter Johnston chaired the IRA/NCTE Joint Task Force on Assessment that resulted in the *Standards for the Assessment of Reading and Writing*. His earlier book, *Knowing Literacy: Constructive Literacy Assessment*, provides great insight and practical suggestions that help teachers learn how to use assessment to help students grow and develop a more thoughtful literacy.

Lea McGee is Professor Emeritus at the Ohio State University and Marie Clay Chair of Reading Recovery and Early Literacy. She is a renowned researcher and her work in early literacy has helped deepen teachers' knowledge about productive literacy practices in preschool through the primary grades. Dr. McGee has extensive experience expanding young children's oral language as they are learning to read and write and she successfully coaches teachers in these practices. In addition to her work in Head Start programs, she successfully brought her knowledge of early literacy to high poverty areas around the U.S. Dr. McGee has authored several books, book chapters and three dozen journal articles, many in the most prestigious journals, such as Reading Research Quarterly and Journal of Literacy Research. She served as president of the National Reading Conference, now renamed as the Literacy Research Association, as well as served as a member of their Board of Directors.
